To maximize the safety of children, families, communities and firefighters, most youth are referred through the juvenile court system. Referrals may also be made by school systems, police, fire departments and family members. Measures are taken to maintain confidentiality. As appropriate, children and families may be referred to additional intervention services through service provider networks and/or the juvenile court system.
